**AN ORDINANCE VACATING WALNUT STREET
AND ALL ALLEYS IN THE ORIGINAL PLAT OF

Seventeen (17) freeholders of Wabash County, IN filed a petition to vacate Walnut Street and all alleys in the Original Plat of Mount Vernon, Wabash County, IN On February 24th, 2014 as required by law and following proper notification to abutting property owners and publication of notice, a public hearing was held on said petition. The Board of Commissioners of Wabash County, Indiana determined that the request to vacate Walnut Street, and all Alleys in the Original Plat of Mount Vernon, Wabash County, IN should be approved as requested.


IT IS NOW ORDAINED AS FOLLOWS:


Legal Description


The streets of Walnut Street being Sixty (60) feet wide each, lying within the Original Plat of Mount Vernon, Wabash County, Indiana as recorded in Plat Book #2, Pages 229 and 230.
All Alleys one (1) rod in width each, lying within the Original Plat of Mount Vernon, Wabash County, Indiana as recorded in Plat Book #2, Pages 229 and 230.
This vacate excludes previous vacates of the Original Plat of Mount Vernon as noted on the Original Plat of Mount Vernon, Wabash County, Indiana as defined and recorded in Misc. Record Book #37, Page 83, dated February 3, 1972.



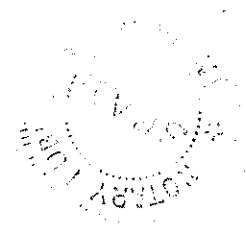
