**AN ORDINANCE VACATING A PART OF THE BELOW DESCRIBED AREA
KNOWN AS CIRCLE DRIVE IN THE PLATTED CONTINUATION OF
THE KINGSTON PARK ADDITION TO LUKENS LAKE, LOCATED IN
PLEASANT TOWNSHIP, WABASH COUNTY, IN.**

Four (4) freeholders of Wabash County, IN filed a petition to vacate a part of the 27 Ft wide street identified as Circle Drive in the platted Continuation of the Kingston Park Addition to Lukens Lake, Pleasant Township, Wabash County, IN.

On September 29th, 2014 as required by law and following proper notification to abutting property owners and publication of notice, a public hearing was held on said petition.

The Board of Commissioners of Wabash County, Indiana determined that the request to vacate a part of the 27 Ft wide street identified as Circle Drive in the platted Continuation of the Kingston Park Addition to Lukens Lake, Pleasant Township, Wabash County, IN.

as outlined in the following legal description, should be approved as requested.

IT IS NOW ORDAINED AS FOLLOWS:

Legal Description

Part of the North East 1/4 of Section 14, Township 29N, Range 5E, platted as the Continuation of the Kingston Park Addition to Lukens Lake, Pleasant Township, Wabash County, IN. Identified as the 27 foot wide street named Circle Drive in the Original Plat of the Continuation of Kingston Park Addition of Lukens Lake as follows: Beginning at the North East corner of Lot 65 and extending the North West line of Lot 65 to the North West side of Lot 63, then South East along Lot 63 to the South West Corner of Lot 63, then South West along the North West side of Lots 3, 2, and 1 to the North West Corner of Lot 1, then North West to the South West corner of Lot 67, then North East along the South East corner of Lots 67, 66, and 64 to the South East corner of Lot 64, then North West along the North East line of Lots 64 and 65 to the point of beginning.

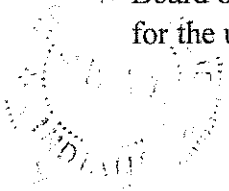
