GENERAL ORDINANCE NO. 2017-85-01

AN ORDINANCE REGULATING TRAFFIC ON COUNTY HIGHWAYS

***(County Highway 400 West between State Highway 15 and County Highway 300 North;
County Highway 300 North between State Highway 15 and County Highway 400 West;
County Highway 200 North between State Highway 15 and County Highway 400 West; and
2,097 feet of Old State Highway 15 between County Highway 200 North and 300 North)***

The Board of Commissioners of Wabash County, Indiana, may adopt ordinances regulating traffic on any highway in the county highway system, subject to I.C. 9-21.

It has been determined that commercial motor vehicles (as defined in I.C. 9-13-2-31) should not be permitted on the following Wabash County, Indiana, highways:


1. County Highway 400 West between State Highway 15 and County Highway 300 North
2. County Highway 300 North between State Highway 15 and County Highway 400 West
3. County Highway 200 North between State Highway 15 and County Highway 400 West
4. Old State Highway 15 for a distance of 2,097 feet (.39/mile) between:
 - (a) its intersection with State Highway 15 located two thousand two hundred thirty-five (2,235) feet (.44/mile) north of County Highway 200 North, and
 - (b) its intersection with State Highway 15 located two thousand two hundred forty (2,240) feet (.42/mile) south of County Highway 300 North.

NOW THEREFORE, IT IS NOW ORDAINED AS FOLLOWS:


1. Commercial motor vehicles (as defined in I.C. 9-13-2-31) are prohibited on the following Wabash County, Indiana, highways:
 - A. County Highway 400 West between State Highway 15 and County Highway 300 North
 - B. County Highway 300 North between State Highway 15 and County Highway 400 West
 - C. County Highway 200 North between State Highway 15 and County Highway 400 West
 - D. Old State Highway 15 for a distance of 2,097 feet (.39/mile) between:
 - (1) its intersection with State Highway 15 located two thousand two hundred thirty-five (2,235) feet (.44/mile) north of County Highway 200 North, and
 - (2) its intersection with State Highway 15 located two thousand two hundred forty (2,240) feet (.42/mile) south of County Highway 300 North.
2. Any person or entity that violates any portion of this ordinance shall be guilty of a Class "C" infraction.
