ORDINANCE NO. <u>2015-85</u>-06

AN ORDINANCE APPROVING USER FEES FOR ACCESS TO RECORDED DOCUMENT INFORMATION

Under a service agreement with Fidlar Technologies ("Fidlar"), the Recorder of Wabash County, Indiana, provides for remote access to recorded document information by professional searchers through Fidlar's Laredo software program.

Under a service agreement with Fidlar, the Recorder of Wabash County, Indiana, provides remote access to recorded document information by the general public through Fidlar's Tapestry II software program.

It is appropriate for the Recorder to charge fees for the access services being provided.

IT IS THEREFOR ORDAINED AS FOLLOWS:

- 1. <u>Establishment of user fees for professional searchers for access to recorded document information.</u>
 - 1.1. The Recorder shall charge fees to professional searchers for remote access to the Recorder's recorded document information through Fidlar's Laredo software program, as follows:

Per-minute plans	Fee
0-100 minutes	\$25/mo. and \$0.20 per minute overage
101-250 minutes	\$50/mo. and \$0.20 per minute overage
251-1000 minutes	\$100/mo. and \$0.15 per minute overage
1001-3000 minutes	\$200/mo. and \$0.12 per minute overage
Unlimited	\$250/mo.

1.2. From such fees collected by the Recorder, the following shall retained by the Recorder and deposited into the Enhanced Access Fund:

0-100 minutes 101-250 minutes	\$13/mo. and \$0.10 per minute overage
251-1000 minutes	\$30/mo. and \$0.10 per minute overage \$55/mo. and \$0.075 per minute overage
1001-3000 minutes Unlimited	\$90/mo. and \$0.06 per minute overage \$103/mo.

and the difference shall be remitted to Fidlar.

- 2. <u>Establishment of user fees for general public for access to recorded information.</u>
 - 2.1. Fidlar shall charge fees to the general public for remote access to the Recorder's recorded document information through Fidlar's Tapestry II software program, as follows:

\$6.95 per search transaction \$1.00 per page print fee

2.2. From such fees collected by Fidlar, the following amounts shall be credited to monies due from the Recorder to Fidlar under the Recorder-Fidlar service agreement:

\$4.25 per search transaction \$1.00 per page print fee

- 3. Restrictions on Use of Recorded Document Information.
 - 3.1. No person or entity other than those authorized by the County in writing may reproduce, store, grant access, deliver, sell, loan or otherwise deliver any recorded document information obtained from any department or office of the County to any other person or entity for any purpose.
 - 3.2. Any person or entity who violates these Restrictions shall be guilty of a Class C infraction.
- 4. <u>Repeal of Prior Ordinances</u>. Any prior ordinances establishing or approving fees for access to recorded document information are hereby repealed.
